


Incidents — Heat Map September 1, 2024 - September 30, 2024

Number of Total Incidents = 534




Incidents by Primary Station

September 1, 2024 - September 30, 2024




Incident Response by Shift

Incident Types



Incident Type Categories





Response times standards are designed to ensure a quick response to the public's request for assistance is achieved. The times listed above are raw, in that, they do not reflect "accepted reasoning" for the delay. At the end of each month, exception reports are filed with the County of El Dorado (Local EMS Agency) by the Department for incidents that are outside the established response time parameters. The reports provide the reasoning why the ambulance did not respond in a timely manner. These reports are then reviewed by the Local EMS Agency and either accepted or denied.

Examples of acceptable reasoning are, but not limited to, weather delays, incorrect address, patient left scene, road construction, incident downgraded in severity requiring no lights/siren (Code 3), etc. Once a decision has been made whether a reason is valid or not, the percentage may be adjusted.



Operations

In September 2024, our department responded to over 500 calls for service and completed hundreds of training hours, as we do every month. I want to highlight four significant events unrelated to training and response:

On September 4, 2024, Captain Tom Anselmo retired after over 26 years of dedicated service to the citizens of El Dorado Hills and the El Dorado Hills Fire Department. The retirement event, held on September 7, 2024 was a beautiful day and well attended. The El Dorado Hills Firefighters Pipes & Drum and the El Dorado Hills Honor Guard performed flawlessly, as Captain Anselmo remarked, "Those two groups are the best thing going in the El Dorado Hills Fire Department."

On September 16, 2024, we honored our fallen brother, Lt. Pete Bertelsen, who lost his life in the line of duty 59 years ago. Each year, we pay tribute to Pete by dedicating a new American flag at Bertelsen Park in his memory.

On September 19, five new Paramedics were sworn in during our monthly Board of Directors Meeting at Station 85. Family members were present to proudly pin Paramedic badges on each of the new recruits. We are thrilled to welcome them to our Fire Family and look forward to the experience and enthusiasm they bring.









Battalion Chief Updates

A-Shift - Chief Antonio Moreno

Incidents:

<u>Landscaping Fire – Western Sierra Drive</u>

Crews responded to a reported structure fire. Battalion 85 arrived and found a landscaping fire involving HVAC units and impinging on the structure. The fire was quickly contained with minimal damage to the house.



<u>Vehicle Accident – Salmon Falls Rd x Estates Drive</u>

A solo non-injury vehicle accident. Engine 84 assisted with traffic control.

<u>Vegetation Fire – Valley View East</u>

Crews responded to a fire sparked from construction equipment. The flames consumed about ¾ of an acre of grass.



<u>Vehicle Accident – Silva Valley Pkwy</u>

Crews responded to a reported vehicle accident onto the playground at Silva Valley School. A solo vehicle had exited the roadway resulting in no injuries to the driver or school children.



<u>Vehicle Accident – Golden Foothill Pkwy</u>

E87, M85, and B85 handled a minor injury accident in the parking lot of Tractor Supply.







Significant Training:

Multi-Company Heavy Lift Drill

Training Update
