SUBJECT: Modification of Tablet Command Two-way Dispatch
Communication Program Purchase

TOPIC

Staff seeks Board authorization to modify and purchase Tablet Command two-way dispatch communication program.

SUMMARY

In September 2024, the Board authorized staff to purchase Tablet Command two-way dispatch program to improve communication capabilities and to improve incident command and crew accountability while operating on emergency incidents.

After staff received Board approval, it was determined that additional devices would be required for a full implementation of all essential resources and proper incident management capabilities. Staff has worked with Tablet Command to ensure that all required licenses and maintenance have been included.

FINANCIAL IMPACT

The initial amount approved in September 2024 was not to exceed \$40,000.00. The updated cost is \$52,750.00. This includes the implementation and first year of service. Future annual costs are estimated to be \$41,750.00.

RECOMMENDATION

Staff recommend that the Board approve the purchase of Tablet Command Two-way Dispatch Communications/Incident Management Software, not to exceed \$55,000.00.
